General Event Information:

Friday, July 9th, 4 p.m. – 10 p.m. & Saturday, July 10, 2021, 12 p.m. – 10 p.m.

- Food Truck Vendors will be accepted until all spaces are full. We will accept vendors on a first come, first served basis.
- Food Truck Vendors MUST have a current Webb City business license and inspection certificate from the Jasper County Health Department in order to vend in Webb City events.
- As a Food Truck Vendor, you are required to be open for all Cruise-A-Palooza hours. Food Trucks will be set up on in King Jack Park. Electricity will be provided. Vendors must provide their own cords.
- Vendors MUST be set up and ready for inspection by 3:30 p.m. Friday, July 9th, or 11 a.m. Saturday, July 10th, 2021.
- Set up time is Friday, July 9th, from 1 – 3:30 p.m. & Saturday, July 10th, 2021 from 8 a.m. to 11 a.m.

Food Vendor Fees:

Food Truck Vendor fees are \$50.00

- Refunds are not available as all funds are committed to the production, promotion, & marketing of the event.
- Payments MUST be made by Wednesday, June 30th, 2021, prior to the event. Non-payment will result in forfeiture of reserved booth space and will be appointed to those next on the waiting list.

Set up/Security:

- Vendors are responsible for set up and tear down of their own booth. All vendors are also responsible for their own products as well as securing any valuables.

Utilities:

- Electricity and water are available. Gas is not available.
 - Water is available at the Spigot located on the Mining Days Building. Vendors must provide their own containers for transporting the water.
