Administrator's Report 01/11/2021

Staff met with representatives of the Cardinal Valley Natural Habitat Restoration Area trustees which includes members of the Department of Natural Resources and U.S. Fish and Wildlife to discuss compost production and invoicing procedures. The current agreement reimburses the city for compost production by tonnage and application costs which we have attempted to monitor. There is discussion of need for a grinder that we will be exploring the possibility of purchasing in the future. Discussion was also focused on the plan for what the long term plan for future maintenance will look like and how it is to be funded. Once all restoration is complete in the next 3-5 years there will be requests for proposals issued by the trustees for land maintenance contracts and it would be staff's hope that Webb City will be in a position to compete for those contracts and maintain the Habitat Area ourselves.

Interest in **Centennial Park** developments is still going strong. Some plans have changed but there always seems to be another plan come forward.

Parks Department will spend the next week or more taking lights down in the park after a very successful Holiday season for the drive thru display. Plans are already moving towards the next years **Polar Bear Express**. We are hopeful to be able to operate the trolley by next year's holiday season.

Joplin Trails Coalition have continued their work to **extend the Frisco Trail** from Crow street along the old Rail easements and stop just north of the city owned Wilsons lake on north Madison. They will be asking the city to make application for a MODOT Transportation grant which they plan on funding the match amount if awarded.

Mets Ambulance Service has removed the old training tower on city owned property behind the Fire Station and has engaged engineers to design the new Mets Ambulance Station planned to be built on city property. The agreement will be brought to council and include a revisionary arrangement should the building ever be abandoned by Mets Ambulance Service. The new location will increase the current ambulance service to two full time units that will help with all areas north in their service area.

Previous meetings

Unveiling of the new Praying Hands Monument located in King Jack Park was held last Sunday. The monument will be a treasure for the City of Webb City for years to come.

Staff have met with state and local agencies regarding the **possible funding of an improved concrete compost pad** located at the Waste Water Treatment Facility. This would aid in the composting project and help with maintenance needs on the equipment. The cost for the concrete would be funded by the trustees of the Cardinal Valley Habitat Restoration Area and the EPA in exchange for continued supplies of soil amendments from the Waste Water Plant.

Bids were received on the Stadium Drive Sidewalk and they came in well under the expected budget amount. The sidewalk will be located on the south side of the roadway and current plans will complete it to Golf Road. Engineers are conducting due diligence in checking quantities and materials in the bids at this time and the contract is expected to be brought to council soon after the first of the year.

Parks Department staff have really worked hard on the **drive thru display of Holiday lights** in King Jack Park. The display opened Thursday evening December 3rd and has had steady crowds each night. During this time there will be music played on FM radio station 98.5 KWEB radio station.

Staff has met with members of the **Sky King Model Airplane club** and are assisting them with support as they seek a grant from the Academy of Model Aeronautics for some project funding at the Webb City location located north off of Sharon Drive.

Cardinal Scale has requested that the portion of Tom Street north of Daugherty to Austin and Austin Street to Main Street be designated as no parking to allow a safe flow of traffic and pedestrians. Austin is already marked no parking on the north side and we will be placing signs for the remainder soon. The company has purchased two lots to the north and will be utilizing those for employee parking in the future.

City Staff have been approached by the Webb City Historical Society who wish to donate the historic Soda Fountain located in the Bradbury Bishop Building and the Webb City Club House building to the City of Webb City to assure lasting care and maintenance of the two. The proposal will be presented to the council at the next meeting.

Community Development has been working to finalize a contract for **Comprehensive Planning Services between the City of Webb City**, Missouri, and the Harry S Truman Coordinating Council. This project is funded through the EDA CARES Grant fund awarded to HSTCC.

Community Development has met with city staff to implement purchase and training on some **sanitary room foggers**. These foggers will be used throughout the city facilities and especially those areas which crowds have or are to gather.

City staff was notified November 12th that there has been a decision made by **our health care provider to request a change in pricing** within the Health Care Coalition which we belong. This request was denied by the coalition and has resulted in the Galena Surgery center becoming an out of network provider. City staff are participating in negotiations and will try to resolve this issue soon.

Water Department staff have been working with engineering and others to develop a plan for construction of a building that will reduce the costs as much as possible but still provide what is needed to have a quality well structure. Once the plan is finalized we hope to have that to council for approval soon.

City staff will be meeting next week with representatives of the **Farmers Market** to try and finalize some needed improvements regarding the parking and entrances to the Farmers Market. We hope to be able to make some improvements in the spring and the Farmers Market has agreed to help fund some of them.

City staff have met with little league board representatives in an effort to prepare better for next year and go over some wishes and desires from both sides. We all agree better communication is needed and we will be working with them to make some needed improvements in the near future. Our goal is to make the sport facilities the best they can be and to begin using the facility for some weekend tournaments in the near future.

Councilman Shull made a motion to authorize the City to accept the donation of the Soda fountain located in the Bradbury Bishop Building and the Webb City Club House building located at 115 N. Madison. Councilwoman Barroeta seconded. The motion carried with seven yes votes.

Storm water- Approve Contract with Anderson Engineering to provide mapping for Storm Water

Councilman Shull made a motion to authorize the Storm Water Department to contract with Anderson Engineering in the amount of \$31,500.00 to create an accurate Storm water mapping system of Webb City. The mapping will provide GIS data for all discharges and outfalls, weirs, cleanouts, manholes, access points, centralized BMPs, inlets, pipes, culvers, and open channels. Councilwoman Darby seconded. The motion carried with seven yes votes.

Parks-Partner with Little League for major Little League filed improvements

Councilman Shull made a motion to authorize the Parks Department to partner with the Little League to share cost to improve the Little League fields. The improvements are: Replace the yellow plastic fence capping with red protective padding, remove the green storage building directly behind home plate, and replace the backstop with a 30" net backstop, move bleachers behind home plate, and new concrete poured around the perimeter. Little League has acquired bids regarding costs of materials and have agreed to provide \$25,000.00 by way of donation from a local bank who in turn will have the field named after them for a designated time period. Councilwoman Darby seconded. The motion carried with seven yes votes.

AN ORDINANCE AMENDING SECTION 375.030 OF THE WEBB CITY CODE REGARDING ILLEGALLY PARKED OR STOPPED VEHICLES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEBB CITY, MISSOURI, AS FOLLOWS:

SECTION 1. That Section 375.030 of the Webb City Code shall be repealed and a new 375.030 shall be adopted in its place as follows:

Whenever any motor vehicle without driver is found parked or stopped in violation of any of the restrictions imposed by ordinance of the City or by State law, the officer finding such vehicle shall take its registration number and may take any other information displayed on the vehicle which may identify its user or owner and shall conspicuously affix to such vehicle a uniform traffic ticket or other citation for the driver or vehicle owner to answer to the charge against him/her within seven (7) days during the hours and at a place specified in the traffic ticket.

SECTION 2. This ordinance shall be in full force and effect from and after its date of passage.

AN ORDINANCE AMENDING THE ZONING ORDINANCE FOR THE CITY OF WEBB CITY, MISSOURI, BY RECLASSIFYING CERTAIN AREAS WITHIN THE CITY LIMITS FROM C-2 GENERAL COMMERCIAL DISTRICT TO R-1 RESIDENTIAL DISTRICT (STEVE FINNEY, 1636 RAINBOW DRIVE, JOPLIN, MISSOURI 64804).

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEBB CITY, MISSOURI, AS FOLLOWS:

SECTION 1. Notice of public hearing having been properly published and recommendation for reclassification having been given after review by the Webb City Planning and Zoning Commission, the Zoning Ordinance for City of Webb City, Missouri, is hereby amended by reclassifying the following described property from C-2 General Commercial District to R-1 Residential District; to wit:

LOCATION OF SUBJECT PROPERTY: South Hall Street, Southeast of Cardinal Drive, Webb City, Missouri 64870

LEGAL DESCRIPTION:

A PARCEL OF LAND LYING IN THE NORTHWEST QUARTER OF SECTION 29, TOWNSHIP 28 NORTH, RANGE 32 WEST, JASPER COUNTY, MISSOURI. BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Early Implementation of FY 20/21 Cost of Living Adjustment

SUBJECT:

As the Pandemic was in its early stages in April of 2020 the decision was made to hold back on expenses as much as possible due to the uncertainty of what the lockdowns and international incident would do to revenues. One of the expenses held back was the implementation of the budgeted cost of living increase that had been scheduled to take effect in May of 2020. City revenues have remained strong and we again budgeted a .02% COLA increase in the current fiscal year.

RECOMMENDATION:

Revenues have remained steady with continued growth here in Webb City. Staff would recommend since the COLA increase was cancelled in 2020 that we have sufficient revenue growth to implement the COLA as of the first full pay week in January.

FISCAL IMPACT:

Early implementation of the 2% COLA, city-wide, will be approximately \$34,500. Need for a budget revision will be considered at a later date.

SUBJECT:

As of January 1st 2021 the Families First Coronavirus Relief Act has expired and included in that legislation was the Pandemic Sick Leave legislation. There are no plans presently to revive or extend the pandemic sick leave into 2021. Currently we have several employees who are approaching a zero balance on their personal sick time accounts. Some have been due to Covid quarantines and isolations but some have been for other reasons. This action would try and lower the chance an employee who has an exposure, of any kind, from possibly returning to work too soon and exposing fellow employees.

RECOMMENDATION:

City Council authorize effective immediately and lasting until the cancellation of the State of Missouri Emergency Declaration that any employee who has expended all of their personal sick time and is required to isolate or quarantine due to a Covid exposure as determined and agreed by both the employee and the City Administrator be allowed to enter into a negative balance on their accumulated sick leave. This negative balance would be replaced upon their return to work under their normal accrual and their sick leave balance would remain at zero until the balance is paid back.

FISCAL IMPACT:

Theoretically the cost to the city would be zero financially over time. There would always be the possibility of an employee not returning after taking such approved sick time or not remaining as an employee long enough to return the sick leave balance.

WITNESSETH:

That for and in consideration of the acceptance of Contractor's bid and the award of this contract to said Contractor by the Owner and in further consideration of the agreements of the parties herein contained, to be well and truly observed and faithfully kept by them, and each of them, it is agreed between the parties as follows, to wit:

The Contractor at his own expense hereby agrees to do or furnish all labor, materials, and equipment called for in the proposal designated and marked:

and agrees to perform all the work required by the contract as shown on the plans and specifications. The "Notice to Bidders", "Plans", and "Proposal", Contract Bond", "Missouri Standard Specifications For Highway Construction, 2019 Edition", "General and Job Special Provisions", "Notice to Proceed", and all change orders are made a part hereof as fully as if set out herein. It is understood and agreed that, except as may be otherwise provided for the "General and Job Special Provision", included in the Proposal, the work shall be done in accordance with the "Missouri Standard Specifications for Highway Construction, 2019 Edition". Said Specifications are part and parcel of this contract, and are incorporated into this contract as fully and effectively as if set forth in detail herein.

The Contractor further agrees that he is fully informed regarding all of the conditions affecting the work to be done, and labor and materials to be furnished for the completion of this contract, and that his information was secured by personal investigation and research and not from any estimates of the Owner; and that he will make no claim against the Owner by reason of estimates, tests, or representation of any officer, agent, or employees of the Owner.

The said Contractor agrees further to begin work not later than the authorized date in the Notice to Proceed, and to complete the work within the time specified in the proposal or such additional time as may be allowed by the engineer under the contract.

The work shall be done to complete satisfaction of the Owner and, in the case the Federal Government or any agency thereof is participating in the payment of the cost of construction of the work, the work shall also be subject to inspection and approval at all times by the proper agent or agents of such government agency including the Missouri Department of Transportation and the Federal Highway Administration.

The parties hereto agree that this contract in all things shall be governed by the laws of the State of Missouri.

The Contractor agrees that he will comply with all federal and state laws and regulations and local ordinances and that he will comply and cause each of his subcontractors, if any, to comply with all federal and state laws and federal regulations and directives pertaining to nondiscrimination against a person on the ground of race, color, religion, creed, sex, age, ancestry, or national origin in connection with this contract, including procurement of materials and lease of equipment therefore, in accordance with the special provisions on that subject attached hereto, incorporated in and made a part of the contract.

The Contractor expressly warrants that he has employed no third person to solicit or obtain this contract in his behalf, or to cause or procure the same to be obtained upon compensation in any way contingent, in whole or in part, upon such procurement; and that he has not paid, or promised or agreed to pay, to any third person, in consideration of such procurement, or in compensation for services in connection therewith, any brokerage, commission or percentage upon the amount receivable by him hereunder; and that he has not, in estimating the contract price demand by him, included any sum by reason of any such brokerage, commission, or percentage; and that all moneys payable to him hereunder are free from obligation of any other person for services rendered, or supposed to have been rendered, in the procurement of this contract. He further agrees that any breach of this warranty shall constitute adequate cause for the annulment of this contract by the Owner, and that the Owner may retain to its own use from any sums due to or to become due hereunder an amount equal to any brokerage, commission, or percentage so paid, or agreed to be paid.

The Owner agrees to pay the Contractor in the amount <u>Two Hundred Forty-Nine Thousand Nine Hundred Ninety-Nine and 00/100</u> Dollars (<u>\$ 249,999.00</u>) as full compensation for the performance of work embraced in this contract, subject to adjustment as provided for changes in quantities and approved change orders.

SUBJECT:

Mets Ambulance Service has one ambulance currently housed within the Webb City Fire Station. Recent growth has shown that additional coverage is needed in Webb City and areas north. Mets is agreeing to build a new station house adjacent to the Fire Department on city owned land that will house two full time ambulance crews. The city would certainly gain an increase in ambulance coverage with this agreement. An agreement would be made in the form of a contract that would spell out any both parties responsibilities should in the future the ambulance service cease to operate from the location.

RECOMMENDATION:

Authorize city staff to work with Mets Ambulance to form an agreement that would be presented to council once completed but to agree that once finalized the council approves of the building of a Mets Ambulance Station on the south west corner of the Fire Station property.

Mets Ambulance will fund the complete project and provide a cost estimate of materials and the agreement will include a depreciated amount for the next 20 years that the city would agree to pay to Mets Ambulance in the event the relationship was severed by either party during that time.
