Administrator's Report 01/25/2021

The new exit road from the **Farmers Market** has been staked out and construction has started to complete this project. The exit will be one way and gravel for the time being but we hope to someday be able to pave the exit and possibly the expanded parking area.

Street crews are working on the area around **Cardinal Scale** to make Tom and Austin a no parking area. This should improve pedestrian safety and make the roads more comfortable for the trucks to navigate.

Engineers along with Councilman Shull and the Fire Department have all been working on the base of the **Praying Hands**. The project is funded by the Dawson Heritage Foundation who owns the structure. The goal is to assure the base remains strong for many years to come.

The notice to proceed on the **Stadium Drive Sidewalk** Project last week and we should be seeing construction on the project in the next few days. The contract was awarded to D&E Plumbing and should have a 90 day completion date once construction begins.

The **Major Field enhancements** regarding the project where the city has partnered with the Little League Baseball organization have been advertised in local publication and also mailed to all known interested vendor. We have scheduled the bid openings at City Hall on February 9th at 10am. Staff have been contacted by local businesses who have advised they will donate the 50% needed by Little League if the bids come in within our expected budget.

City staff have been working to make plans for returning to our **normal festival and activities** for later in 2021. It is our hope that by the summer we will be able to conduct the festivals as close to normal as possible.

City staff are continuing to work with **Mets Ambulance** Service to develop an agreement that would be comfortable for both parties regarding the construction of a new Ambulance Station on Webb City Fire Department property.

Interest in **Centennial Park** is still going strong. Staff have met with several new interested parties regarding future development within the Centennial Retail development. We hope to have some finalized plans for future growth very soon.

Previous meetings

Staff met with representatives of the Cardinal Valley Natural Habitat Restoration Area trustees which includes members of the Department of Natural Resources and U.S. Fish and Wildlife to discuss compost production and invoicing procedures. The current agreement reimburses the city for compost production by tonnage and application costs which we have attempted to monitor. There is discussion of need for a grinder that we will be exploring the possibility of purchasing in the future. Discussion was also focused on the plan for what the long term plan for future maintenance will look like and how it is to be funded. Once all restoration is complete in the next 3-5 years there will be requests for proposals issued by the trustees for land maintenance contracts and it would be staff's hope that Webb City will be in a position to compete for those contracts and maintain the Habitat Area ourselves.

Parks Department will spend the next week or more taking lights down in the park after a very successful Holiday season for the drive thru display. Plans are already moving towards the next years **Polar Bear Express**. We are hopeful to be able to operate the trolley by next year's holiday season.

Joplin Trails Coalition have continued their work to **extend the Frisco Trail** from Crow street along the old Rail easements and stop just north of the city owned Wilsons lake on north Madison. They will be asking the city to make application for a MODOT Transportation grant which they plan on funding the match amount if awarded.

Unveiling of the new Praying Hands Monument located in King Jack Park was held last Sunday. The monument will be a treasure for the City of Webb City for years to come.

Staff have met with state and local agencies regarding the **possible funding of an improved concrete compost pad** located at the Waste Water Treatment Facility. This would aid in the composting project and help with maintenance needs on the equipment. The cost for the concrete would be funded by the trustees of the Cardinal Valley Habitat Restoration Area and the EPA in exchange for continued supplies of soil amendments from the Waste Water Plant.

Parks Department staff have really worked hard on the **drive thru display of Holiday lights** in King Jack Park. The display opened Thursday evening December 3rd and has had steady crowds each night. During this time there will be music played on FM radio station 98.5 KWEB radio station.

Staff has met with members of the **Sky King Model Airplane club** and are assisting them with support as they seek a grant from the Academy of Model Aeronautics for some project funding at the Webb City location located north off of Sharon Drive.

City Staff have been approached by the Webb City Historical Society who wish to donate the historic Soda Fountain located in the Bradbury Bishop Building and the Webb City Club House building to the City of Webb City to assure lasting care and maintenance of the two. The proposal will be presented to the council at the next meeting.

Community Development has been working to finalize a contract for **Comprehensive Planning Services between the City of Webb City**, Missouri, and the Harry S Truman Coordinating Council. This project is funded through the EDA CARES Grant fund awarded to HSTCC.

Community Development has met with city staff to implement purchase and training on some **sanitary room foggers**. These foggers will be used throughout the city facilities and especially those areas which crowds have or are to gather.

City staff was notified November 12th that there has been a decision made by **our health care provider to request a change in pricing** within the Health Care Coalition which we belong. This request was denied by the coalition and has resulted in the Galena Surgery center becoming an out of network provider. City staff are participating in negotiations and will try to resolve this issue soon.

Water Department staff have been working with engineering and others to develop a plan for construction of a building that will reduce the costs as much as possible but still provide what is needed to have a quality well structure. Once the plan is finalized we hope to have that to council for approval soon.

MOTIONS

Admin-An Early implementation of a 2% Cost of Living Adjustment (COLA) increase for all city employees.

Councilwoman Barroeta made a motion to authorize the Administration Department to give the 2% COLA increase to all city employees, effective the first full pay period in January 2021 instead of May 2021. (The city did not give a COLA increase in 2020, due to the possible unexpected cost of the COVID 19). Councilman Edwards seconded. The motion carried with six yes votes.

Admin-Families first Coronavirus Relief Act paid sick time adjustment

Councilwoman Barroeta made a motion to authorize the Admin Department to revive or extend the pandemic sick leave into 2021 due to several employees who are approaching a zero balance on their personal sick time accounts. Due to the COVID exposure employees are required to isolate or quarantine. The City Administrator will be the one to allow the employee to enter into a negative balance on their accumulated sick leave. This negative balance would be replaced upon their return to work under their normal accrual and their sick leave balance would remain at zero until the balance is paid back. Councilman Edwards seconded. The motion carried with six yes votes.

AN ORDINANCE RENEWING A SPECIAL USE PERMIT FOR A CERTAIN TRACT OF REAL ESTATE WITHIN THE CITY OF WEBB CITY, MISSOURI (LAVONNA PREBLE, P.O. BOX 368, WEBB CITY, MO 64870).

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF WEBB CITY, MISSOURI AS FOLLOWS:

SECTION 1. By action of the City Council, a Special Use Permit is hereby renewed for the following described real estate: 406 North Webb, Webb City, Missouri, being more particularly described as follows, to-wit:

All of Lot Numbered Thirty-Five (35) in Webb's Third Addition to Webb City, Jasper County, Missouri, according to the recorded plat thereof.

SECTION 2. The terms and conditions of the Special Use Permit renewed in Section 1 above are as follows, to-wit:

- A. Said Special Use Permit shall be personal to LAVONNA PREBLE and shall not be assigned provided that LAVONNA PREBLE may lease the premises to a third party operating a business consistent with the terms of this Special Use Permit.
- B. The use upon said real estate is for the purpose of operating a reflexology and massage business.
- C. Said Special Use Permit hereby renewed shall extend for a period of two (2) years from passage of this Ordinance, unless revoked for non-compliance with the conditions or restrictions imposed herein.

The police department is seeking the Council's approval to apply for grant funding from the Missouri Department of Transportation – Highway Safety Division.

BACKGROUND:

Over the past sixteen years the police department has received \$457,156 in grants from the Division of Highway Safety for DWI Saturation Patrols (Wolfpacks), Hazardous Moving Violation Enforcement (HMV), and enforcement equipment.

This year the police department is applying for funds to conduct DWI Wolfpacks, Speed Enforcement, and Hazardous Moving Violation (HMV) Enforcement, along with funds to purchase equipment to be used during these enforcement activities. The police department may be required to provide up to 50% matching funds. These matching funds would be included in the police department's fiscal year 2021-22 budget.
