Administrator's Report 11/24/2025

The Fire Department will be having the ribbon cutting and dedication ceremony for the new training facility on November 25th, 2025, at 10:00 AM.

We hope everyone can make it out as this will be a special day in the history of the Webb City Fire Department.



The Parks Department has completed the tree transplant in front of the W Club. The tree was moved from another section in the park and will be used for years to come as a focal point for the Holiday light display.

Be sure to come out the evening of November 29th for the first time lighting of this tree along with the entire park as the Mayor will be kicking off the Holiday Season. We anticipate starting about 5:30pm.

Water Department staff report that the repairs to well #8 (discussed in last council meeting) are complete. Unfortunately, the motor and all wiring had to be replaced. The well is back online and operating at full strength, but the cost was \$55,205. This along with the \$38,000 it took last week to drop well #9 will definitely impact our water repair budget this year. Well #9 is showing a good improvement in running time and the air issue is no longer a problem. Currently our run time on our wells are less than 12 hours, so the repairs are certainly helping.

Public Works reports that all connections on the **Tom Street main line replacement are complete. We are now preparing the street for pavement.** We will continue crack sealing to prepare for the upcoming freezing weather and also with leaf pickup starting December 1st they are busy checking the equipment.

Previous Meetings

Polar Bear Express tickets went on sale Saturday morning and were completely sold out in less than two hours. The first annual **Pumkin Carving event** was enjoyed by over 140 participants and definitely will be back next year.

Badges and Burgers was a big success this year. Our staff raised over \$5,000 for local charities and did that with donations from our employees of over \$840.00. This was done through payroll deductions that our employees volunteered for.

The Fire Department reports October is Fire Safety Month and they dedicate one week of it each year to reach out to the schools and talk with the students about fire safety. This year we had several visits to most of the elementary schools and even a home school group that visited us at the station. This is a great time for the Fire Department to help educate not only the students, but parents and teachers as well about safety. They also use this time to talk about all safety hazards in the home besides just fire. It's always a fun time working with the students.

City staff have been working alongside the construction crews for the new Fiber Optic being installed here in Webb City. We are aware of the multiple cuts being made in the roadways. We have asked that they severely limit them to only those that are necessary. We have asked to be notified prior to any street cut to make sure we concur that it is needed. Unfortunately, DigRite procedures require a pothole be dug when cross bore drilling such as across a street. We are looking for options, but the contractor has done a good job of filling the cuts made thus far and we have advised them they have made those cuts and will be required to maintain them.

Water Department has completed almost all of the service installs required on the new water main along Tom Street. This line is expected to be fully operational on November 17th.

Council will be asked to approve an upgrade to well #9 as it has been the cause of some air entering our system. Water crews have spent time looking for the cause and now believe that lowering well #9 would not only solve the air issue but also increase the available run time.

Well #8 is also giving us some problems. The electrical circuit is grounding out and shutting the motors down. That, or the motor is going bad. We are having it pulled and should have an answer before Monday's meeting. Only good news to that is this time of year is a good time to maintenance the wells. Water usage is down and our MOAM backup is minimal.

City staff are working with bond council and financing options regarding a request from the 201 Wastewater Center Creek Board that we explore funding a possible \$12 million upgrade to the wastewater plant **improvements** that came outlined in the recent 30-year needs assessment engineering plan completed by Algeir Martin. If the board decides to move forward on this each city council of the participating members would be required to approve and place on the ballot a question to approve the project. Most likely this would be November 2026 before the State

revolving fund request and bond questions could be completed. Staff will continue to update as the project moves forward.

It's that time of year again. Parks Department has started the work on this year's Holiday Displays in King Jack Park. Couple of changes in the works for this year are some additional lighted trees in the front of the park and as of now we plan to move the mayor's lighting ceremony to the W Club in case of bad weather. It was extremely cold last year. Following the lighting we will all then go to the pavilions for the first rides on the Polar Bear Express this year. This year's lighting ceremony will be held on Saturday evening November 29th at 5:40pm.

The W Club has been booking up several team practices and birthday parties in the upcoming weeks. We are now coordinating a pickleball tournament to be held on Nov 22nd, in addition to coordinating a Zumba workout event November 23rd. The plan is to start an adult basketball league & volleyball league starting mid to late November and noon time adult basketball league starting in December.

Mr. William Kulju, 106 N. Pennsylvania shared with council his concerns about the properties Mr. Slaughter owns in Webb City. Mr. Kulju stated he thought that the "Chinn House" 302 S. Pennsylvania, was not sold because of the duplexes south of the "Chinn House" as they are owned by Mr. Slaughter and not maintained well. Mr. Kulju also shared photos with the council of other properties owned by Mr. Slaughter as he believes every homeowner should be held accountable and to the same standards as other properties owners.

"AN ORDINANCE authorizing and providing a contract between the City of Webb City, Missouri (hereinafter sometimes called the CITY) and The Empire District Electric Company (hereinafter sometimes called the COMPANY), its successors or assigns, for electric service and equipment to light the CITY's streets, alleys, and public ways, electric service for light and power for the CITY's parks, other properties and public places, for a term of years, and specifying the prices to be paid for such lighting and power service, and the terms and conditions of such contract; and in consideration of COMPANY's covenants and obligations contained herein and COMPANY's acceptance of the terms and conditions contained herein for the establishment, operation and maintenance of the Company's facilities within the CITY; except providing further that nothing herein shall prohibit the CITY from lawfully collecting and Occupation Tax, License Tax, motor vehicle license fees and any ad valorem tax on the COMPANY's real estate and personal property."

"BE IT ORDAINED by the City Council of the City of Webb City, Missouri as follows."

ARTICLE 1: That said City of Webb City, Missouri is hereby authorized and does contract with The Empire District Electric Company, a corporation, its successors or assigns for electric service and equipment to light the CITY's streets, alleys and public ways; and electric service for light and power for the CITY's parks, other properties and public places.

ARTICLE 2: The CITY and the COMPANY mutually agree that this ordinance will constitute a contract and that all of its terms, conditions and provisions for payment shall be in effect for a period of two (2) years from the date of execution hereof as provided in Article 13; and shall be automatically extended for a further period of two (2) years from each successive expiration date unless one party shall notify the other in writing not less than sixty (60) days prior to any such expiration date of its desire to terminate this agreement; and further providing that this contract shall not be effective for a total period exceeding ten (10) years; and further provided that the terms of Article 5 are not limited by the terms of Article 2.

ARTICLE 3: The COMPANY agrees to furnish and the CITY agrees to use and pay for the street lighting service described in SPL Street Lighting data sheet, designated Exhibit A, attached hereto and made a part hereof, and for any and all additional street lighting service subsequently agreed upon under the terms of this contract or any amendment hereto, according to the rates and conditions set out in the Municipal Street Lighting Service Schedule SPL as now or in the future approved by competent authority having jurisdiction.

ARTICLE 4: When, by agreement with the CITY, the COMPANY shall install, own, operate and maintain street lights charged for under Schedule SPL, or is required to provide special or excessive electric facilities to serve CITY owned street lighting systems served under Schedule SPL, there shall be charged, in addition to the rates hereinbefore set out, a Facilities Usage Charge, payable as herein provided, as mutually agreed upon by the parties.

ARTICLE 5: It is agreed that the Facilities Usage Charge shall be computed at the rate set forth in Municipal Street Lighting Service Schedule SPL as now or in the future approved by competent authority having jurisdiction. Said rate shall be applied to the investment in COMPANY owned street lights and special or excessive electric facilities to serve CITY owned street lights utilized by the CITY under Schedule SPL. The total of such investment by the COMPANY is \$613,732.00 and the total of the Facilities Usage Charge shall be \$55,235.88 until additional street lights are requested by the CITY and installed by the COMPANY and this contract amended by written agreement. Such Facilities Usage Charge shall be due and payable by the CITY of Webb City, Missouri, to the COMPANY so long as the street lights and/or special electric facilities herein referred to in Article 4 and its references shall be utilized by said CITY, but for a term of not less than ten (10) years from date hereof, and shall be payable as provided in said Schedule SPL.

ARTICLE 6: The COMPANY agrees to change the location of any street lamp in use upon the written request of the CITY, provided the CITY shall pay the COMPANY the actual cost thereof.

ARTICLE 7: The COMPANY shall furnish and the CITY shall take and pay for all electric service for municipal use, other than street lighting service, as may be required from time to time by the CITY in its parks, buildings, properties and public places, according to the rates and provisions of the filed standard rate schedules of the COMPANY, and subject to the valid rates, rules and regulations of any competent regulating authority of COMPANY.

ARTICLE 8: The rates and conditions set forth in the attached Schedule SPL, and all applicable rates, rules and regulations of the COMPANY filed with competent authority having jurisdiction as now or hereafter promulgated, shall be allowed provided the CITY utilizes the COMPANY's service for its entire requirements for electric or power service and the COMPANY serves the CITY under the provisions of an electric franchise having an original term of not less than ten (10) years; except for providing that nothing herein shall prohibit the CITY from lawfully collecting an Occupation Tax, License Tax, motor vehicle license fees or any ad valorem tax on the COMPANY's real estate and personal property.

ARTICLE 9: The COMPANY agrees to protect the CITY and save it harmless from any and all loss, damage or expense to persons or property which is caused by the negligence of the COMPANY in its use or maintenance of any and all equipment owned by it, and used to supply service under this contract.

The CiTY agrees to protect the COMPANY and save it harmless from any and all loss, damage or expense to persons or property which may arise due to the use or maintenance of any street lighting equipment owned by the CITY, unless such loss, damage or expense be the sole and proximate result of the COMPANY's negligence.

ARTICLE 10: The COMPANY agrees to exercise reasonable care in maintaining the facilities to be maintained by it and in rendering the service to be rendered by it in the performance of this contract, so that the said service and said facilities may be furnished and maintained in a satisfactory manner.

ARTICLE 11: The CITY agrees for the term of this contract to utilize the COMPANY's service for the purpose herein set forth, and that the electric service rendered the CITY hereunder shall be for its use alone, and shall not be resold, and that it will utilize no electric or power service from a source other than the COMPANY.

ARTICLE 12: This contract supersedes all prior representations or agreements, either verbal or written concerning matters herein contained, and shall inure to the benefit of and be binding upon the respective legal representatives, successors and assigns of the parties hereto.

ARTICLE 13: Upon the passage and approval of this Ordinance, two copies thereof shall be prepared by the Clerk, and shall be signed in the name of the CITY by the Mayor with the seal of the CITY affixed, attested by the Clerk, and shall also be signed for

Police Department Vehicle Purchase 3-SUVs November 24, 2025

SUBJECT:

Allow the police department to purchase three new all-wheel drive police rated SUVs.

BACKGROUND:

The police department budgeted \$151,588.00 to purchase three vehicles during this fiscal year. We are purchasing the three new vehicles and surplusing five vehicles that are high mileage, becoming costly to maintain, and had been surplussed in previous years.

We advertised in the Jasper County Citizen - Carl Junction newspaper for two weeks and on the police department's Facebook page. We also solicited bids from several dealerships in the area; we received two bids on this purchase. The all wheel drive vehicles will give us increased mobility during inclement weather. We have opted for the SUVs because they are roomier and are able to carry all of the officer's necessary equipment.

MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION SHOW ME ZERO PROGRAM AGREEMENT

THIS AGREEMENT is entered into by the Missouri Highways and Transportation Commission (hereinafter, "Commission") and the City of <u>Webb City Police Department</u> a municipal corporation in the State of Missouri (hereinafter, "City")

WITNESSETH:

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations in this Agreement, the parties agree as follows:

- (1) <u>PURPOSE</u>: The Commission has authorized State Road Funds to be used to support regional Show Me Zero activities. The purpose of this Agreement is to grant the use of such State Road Funds to the **City**.
- (2) <u>ACTIVITY:</u> The State Road Funds, which are the subject of this Agreement, will support the following activity to further Missouri's Show Me Zero Program: **Purchasing of a patrol car lighting package.**
- (3) <u>INDEMNIFICATION</u>: To the extent allowed or imposed by law, the <u>City</u> shall defend, indemnify and hold harmless the Commission, including its members and department employees, from any claim or liability whether based on a claim for damages to real or personal property or to a person for any matter relating to or arising out of the <u>City</u> 's wrongful or negligent performance of its obligations under this Agreement.

(4) <u>INSURANCE</u>:

- (A) The <u>City</u> is required or will require any contractor procured by the <u>City</u> to work under this Agreement:
- (1) To obtain a no cost permit from the Commission's district engineer prior to working on the Commission's right-of-way, which shall be signed by an authorized contractor representative (a permit from the Commission's district engineer will not be required for work outside of the Commission's right-of-way); and
- (2) To carry commercial general liability insurance and commercial automobile liability insurance from a company authorized to issue insurance in Missouri, and to name the Commission, and the Missouri Department of Transportation and its employees, as additional insureds in amounts sufficient to cover the sovereign immunity limits for Missouri public entities (\$600,000 per claimant and \$4,000,000 per occurrence) as calculated by the Missouri Department of Insurance, Financial Institutions and Professional Registration, and published annually in the Missouri Register pursuant to Section 537.610, RSMo.

- (B) In no event shall the language of this Agreement constitute or be construed as a waiver or limitation for either party's rights or defenses with regard to each party's applicable sovereign, governmental, or official immunities and protections as provided by federal and state constitution or law.
- (5) <u>AMENDMENTS:</u> Any change in this Agreement, whether by modification or supplementation, must be accomplished by a formal contract amendment signed and approved by the duly authorized representatives of the <u>City</u> and the Commission.
- (6) <u>COMMISSION REPRESENTATIVE</u>: This Commission's District Engineer is designated as the Commission's representative for the purpose of administering the provisions of this Agreement. The Commission's representative may designate by written notice other persons having the authority to act on behalf of the Commission in furtherance of the performance of this Agreement.
- (7) <u>NONDISCRIMINATION CLAUSE</u>: The <u>City</u> shall also comply with all state and federal statutes applicable to the <u>City</u> relating to nondiscrimination, including, but not limited to, Chapter 213, RSMo; Title VI and Title VII of the Civil Rights Act of 1964 as amended (42 U.S.C. Sections 2000d and 2000e, *et seq.*); and with any provision of the "Americans with Disabilities Act" (42 U.S.C. Section 12101, *et seq.*).
- (8) <u>ASSIGNMENT:</u> The <u>City</u> shall not assign, transfer or delegate any interest in this Agreement without the prior written consent of the Commission.
- (9) <u>LAW OF MISSOURI TO GOVERN:</u> This Agreement shall be construed according to the laws of the State of Missouri. The <u>City</u> shall comply with all local, state and federal laws and regulations relating to the performance of this Agreement.
- (10) <u>CANCELLATION:</u> The Commission may cancel this Agreement at any time for a material breach of contractual obligations or for convenience by providing the <u>City</u> with written notice of cancellation. Should the Commission exercise its right to cancel the contract for such reasons, cancellation will become effective upon the date specified in the notice of cancellation sent to the <u>City</u>.
- (11) ACCESS TO RECORDS: The **City** and its Contractors must maintain all records relating to this Agreement, including but not limited to invoices, payrolls, etc. These records must be available at no charge to the Commission and/or their designees or representatives during the period of this Agreement and any extension, and for a period of three (3) years after the date on which the **City** receives reimbursement of their final invoice from the Commission.
- (12) <u>REIMBURSEMENT:</u> With regard to work under this Agreement, the <u>City</u> agrees that funds to implement Show Me Zero activities shall only be available for reimbursement of eligible costs which have been incurred by <u>City</u>. The <u>City</u> shall supply to the Commission copies of all bid information; purchase orders; invoices; and name, date, hours worked, and rate of pay (on Program Agreements that include salaries). Any costs incurred by <u>City</u> prior to authorization and notification to proceed from the Commission are **not** reimbursable costs. The Commission shall not be responsible for

any costs associated with the activity herein unless specifically identified in this Agreement or subsequent written amendments. The Commission shall not provide more than <u>Six Thousand Twenty Four and 80/100</u> dollars (\$6,024.80) for this Show Me Zero safety project.

- (13) <u>USE OF FUNDS</u>: Any employee of <u>City</u> whose salary or wages are paid in whole or in part with federal funds is prohibited from participating in certain partisan political activities, including, but not limited to, being a candidate for elective office pursuant to Title 5 United States Code (hereinafter, "U.S.C."), Sections 1501-1508. If an employee of <u>City</u> participates in activities prohibited by the Hatch Act, <u>City</u> shall no longer pay that employee's salary or wages with federal funds unless the requirements of 5 U.S.C. Sections 1501-1508 are not applicable to that employee pursuant to 5 U.S.C. Section 1502(c).
- (14) <u>INSPECTION OF IMPROVEMENTS AND RECORDS:</u> The <u>City</u> shall assure that representatives of the Commission shall have the privilege of inspecting and reviewing the work being performed per this Agreement. The <u>City</u> shall also maintain all financial documents, reports, papers and other evidence pertaining to costs incurred in connection with this Program Agreement, and make such materials readily available for review at reasonable times and at no charge during this Agreement period and for three (3) years from the date of final payment under this Agreement, for inspection by the Commission or any authorized representatives of the State of Missouri; copies shall be furnished, upon request, to authorized representatives of the Commission or State.
- (15) VENUE: It is agreed by the parties that any action at law, suit in equity, or other judicial proceeding to enforce or construe this Agreement, or regarding its alleged breach, shall be instituted only in the Circuit Court of Cole County, Missouri.
- (16) <u>FINAL AUDIT:</u> The Commission may, in its sole discretion, perform a final audit of project costs. The <u>City</u> shall refund any overpayments as determined by the final audit.
- (17) <u>SOLE BENEFICIARY</u>: This Agreement is made for the sole benefit of the parties hereto and nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the Commission and the <u>City</u>.
- (18) <u>AUTHORITY TO EXECUTE</u>: The signers of this Agreement warrant that they are acting officially and properly on behalf of their respective institutions and have been duly authorized, directed and empowered to execute this Agreement.
