#### Administrator's Report 06/26/23

Work is moving forward on the **sun shade being built for the amphitheater**. We were able to get the custom shade material delivered with time to spare and the poles are being constructed this week. We certainly hope to have it available for all the activities coming up in July.

Final preperations are ongoing now for the **annual CruisaPalooza Festival** to be held in King Jack Park Friday and Saturday July 14<sup>th</sup> and 15<sup>th</sup>. AS of now there are over 80 vendors who have signed up and plan to attend. The fun will go until 10pm on both days with lots of activities for the entire family.

**Randy Haas completed his last day last week as our Habitat Manager** and is now retired and already living in Florida. We will miss him but we were lucky to have John Nichols available to take over the project. John is very familiur witht the entire opertation since he was one of the original founding board members when he worked for the Department of Natural resources. We hope to have the final agreement outlinign the trustees support for the Cardinal Valley Natural Habitat for years to come available soon. It is currently in the comment period with the U. S. Fish and Wildlife.

The Parks Department has been busy **replacing the shrubbery and flowers** around the Kneeling Miner Statue after last winter's toll damaged most all the plants. The area has a new bright look and we would like to also thank Henkle's Ace Hardware for their assistance with the project.

The Statue was then also decorated by the Webb City/Carl Junction Rotary on Memorial Day with 50 Flags in honor of area veterans on display.

Staff are excited to announce the **new city website** is now up and running! Please go to www.webbcitymo.org to check it out. Each department has been asked to look for any issues and improvements that may be needed.

**New summer hours have been started at the recycle gate** location. They are now open the following hours for the summer months. 11am – 6pm Monday thru Friday and 9am-2pm on Saturday and Sunday. The recycling collections have also increased and we are working with our waste hauler to try and get additional roll offs or increased removals.

Waste Water staff will be out this next few weeks in the north and east part of the city putting the new Vactor Cleaning truck to use. We have identified several locations that are in need of roots being cleaned out and removed and pipe inspections being completed.

#### **Previous Meetings**

**If you see people climbing on the water tower** this week do not be alarmed. We are in the process of having the tower cleaned for regular maintenance. There will be divers actually working inside the tower to inspect and clean the lining.

**The Police Department will be conducting Children Fingerprint ID kits** at the Farmers Market the next several weeks. Also if one cannot make it to the Farmers Market the Identification kits are free and available anytime at the Police Station.

#### Splash Pad is open for the summer and already enjoyed by many!

City staff assisted our solid waste contractor all last week and the city wide trash pickup appears to have been a success with very few issues arising. The electrical waste collection was conducted Saturday at Public Works.

City staff hosted the first meeting with the staff of the Farmers Market. Discussion was mainly focused on maintenance issues that the city could possibly help on. The floors in the Kitchen appear to be in need of some repairs along with some electrical issues they have been having with around the pavilions. A diagram was requested that will outline where the issues are occurring and what appliances are being used during the time that the issue is occurring. This will give our city electrician a chance to see if there is anything we can do to help.

The rehab of the Praying hands is complete. One can certainly tell the new bright white color on the surface. Work has been completed by the owner on the structure that was needed underneath and the electrical circuit has been installed to supply power to a fan underneath the structure to hopefully slow any further damage.

This Saturday morning members of the **Webb City/Carl Junction Rotary club** will be installing the plastic support pipes to hold the memorial Flags which are part of a program they are kicking off this year in Webb City and Carl Junction.

**First round of 2023 paving** has been scheduled. The total cost of these overlays will be \$600,238.95. The FY 22/23 budget contains \$500,000. Staff recommends council approve the use of ARPA funds to cover the amount over budget. We hope to move forward with the aid of the recent roadway conditions study, to look for additional areas following this round. This will take considerable prep time and effort from our public works staff and did not want to get extended out too far. (Update, we are working with the pavers to secure as early a start date as we can)

**Some good news for down town**. The two buildings that were sold several years ago located at 27 and 29 South Main look to have some improvements soon. Public works staff have been communicating with the property owner who hopes to have the improvements completed this year.

**The Georgia City Bridge has been repaired and is now back open**. \$3,200 was the cost for labor and material to replace the railings and posts plus a few of the deck boards were also replaced. We will be watching it close to see if we need to make additional repairs.

**The Police Department has received a request from the Webb City Schools for an additional School Resource Officer**. They will continue to fund all of the resource officer positions at 50% of all pay and benefits. Proposed position is on the agenda for council consideration.

Well #15 was originally located next to the Water Tower and constructed in the 1960's. This well had to be shut down for approximately the last 15 years due to a bent casing preventing the pumps from being dropped below 750 feet which is at the current water table level. At the time of it being shut down the water quality and quantity was good. Public Works has requested bids to have a new well drilled at the same location down to approximately 1100 feet along with the testing and casing necessary. If successful this could be a good producer of water once new pumps and well house would be constructed. The volume and quality tests would be completed with this contract being presented to council.

**3% retail tax ballot question was passed by voters**. We will be working on the ordinance for Council approval in the future.

The Webb City Fire Department responded to a total of 183 calls for service during the month. See attached sheet for breakdown information.

We now have the new communications/Battalion Chief vehicle in service. It has been working well for our needs.

We have started hydrant inspections for the year; however, we are not flow testing them currently due to the ongoing drought conditions. We will flow test in the event of a construction or fire protection system project.

We have assisted the schools with 'water day' during the last week of school. This has been a good opportunity to work with the schools to provide some fire education as well as have some fun.

A few members have been able to gain some outside training from different training providers to bring back some good knowledge to be put into use here at Webb City.

220 hours of department training and 20 hours of Public Relations has been conducted and we continue to assist the other departments in the city as needed.



In addition, the Building Official shall post notice of said hearing and the reasons therefor by placing a sign on the subject premises.


