Administrator's Report 08/11/2025

City staff have discussed future **needs within our water distribution system** and feel that one area of concentration should be our daily storage availability. We have looked at two needed improvements and those are first to find a way to utilize the 300,000 gallon water tower on South Hall Street. This tower has been inoperable due to a height and pressure conflict with the million Gallon tank on Tracy Street. The second issue is as the city continues to grow we will need additional storage and pressure in the near future. Staff have discussed the possibility of conducting a preliminary engineering report to determine what our best and most economical solutions would be to accomplish these two goals. The proposal will be on the agenda for council to consider.

Parks Department has reported that the contractor installing the new playground equipment is now on site at Hatten Park and it is believed all installation will be completed this week. Work will continue to improve the tennis courts.

Last November the City Council agreed to accept ownership of the Jack Dawson Painting that is currently housed in the Mid Missouri Bank building located at 100 S. Main Street. **The Dawson Family has now requested that the painting be donated to the Schroeder Family Exploreum** located at 300 S. Main in Joplin. The painting will be on display for all to enjoy who visit the museum area and it will be in a location where it can be maintained and preserved.

Staff have worked with WOW Printing LLC who have submitted a proposal to produce & install a mural framing system for on the building located north of the Route 66 Gas Station and Chamber office. A mural banner will be installed within the framing system. This allows the city to interchange the banner/design to fit with seasons, events, and/or themes. The initial design is a historic postcard look celebrating the centennial year of Route 66. City Council approved up to \$15,000 for a downtown mural and this project is well under that budget. Staff are also working on a painted mural to be placed on the concrete trestle along Daugherty (Old Route 66). The downtown mural will be on the agenda for council to consider.

Public Works crews have been busy painting crosswalks and other preparations for the upcoming start of school. Other items they have been working on has been the storm box replacement that was needed on Mount Hope Road. The road was starting to cave, and the complete replacement of the culvert became necessary.

Engineering plans have been completed on the new water line to be installed on Tom Street is complete. Crews are now waiting for DNR site approval before starting this project. While waiting for that approval they have been busy replacing meters as we continue our goal of staying up to date on old meters and replacing them as needed.

Fire Department reports their first Fire Academy to have been a success with five of the first seven graduates' passing their State practical tests and we anticipate the remaining two to retest and pass next week. (Update: all have now passed their Missouri State tests!)

Roads are prepped and ready. We anticipate the pavers to be in town next week to complete the second round of paving which consists of the major streets being Webb Street and 4th Street.

We would like to **thank the Fire Department** for their assistance in keeping the grass at the new W Club watered. They have been bringing water to the site each morning to make sure the grass has the best opportunity to survive in this recent heat.

The Joplin Trails Coalition announced last week that they have issued a contract for the first phase of the walking trail to be constructed on city owned property on North Madison. This eventually will be a walking trail across Center Creek to allow trail enthusiasts to connect to the North to the Ruby Jack Trail. Maps will be available at the meeting.

Much discussion and testing has taken place regarding any levels of toxicity within the fish at all of our city owned lakes. It is good to report so far all tests have come back with no concerning levels of any heavy metals or toxins. We are working with DNR and the Department of Conservation to determine what the best fishing ordinance we can come up with regarding catch and release or harvest limits at our lakes. The MDC plans to host several fishing and children events at our lakes soon and will be determining how to best stock the lakes.

Waste water crews have been working to install a couple new manholes in locations determined to have been found to have issues because of very long runs. Once that is complete we will be focusing on some major maintenance projects that will include removing roots and other obstructions in the entire system.

Parks Department would like to extend a thank you to our Habitat Division for their continued assistance this year bringing the large winged tractor and brush hog to the park. This has really relieved some of the staff mowing time.

Parks department have had a need for a small building in the softball complex for storage and also and air-conditioned area for the officials to relax between games. Muskrat Roofing has volunteered to build the building if we can provide the materials. Little League has also agreed to donate \$1,500 of the costs which are estimated at \$5,000.

SUBJECT:

The Police Department is seeking the Council's approval to accept \$94,720.29 in grant funding from the Missouri Department of Transportation and purchase equipment using the City's procurement process.

BACKGROUND:

The Missouri Department of Transportation will fully fund saturation patrols (driving while intoxicated wolf packs) and hazardous moving violation enforcement patrols from October 1, 2025, through September 30, 2026. Funding awarded for saturation patrols is \$53,579.62, hazardous moving violation enforcement patrols is \$35,000.00 and \$6,140.67 for in-car computer replacement. Funding included in these grants will go toward the purchase of three in-car camera systems (\$18,379.62) and three computer tablets (\$6,140.67). The City of Webb City is not required to provide any matching funds to claim this award.

RECOMMENDATION:

Allow the Webb City Police Department to accept grant funding from the Missouri Department of Transportation.

Allow the Webb City Police Department to purchase equipment awarded in this grant using the City's procurement process.

FISCAL IMPACT:

The police department will budget \$94,720.29 in their 2024-25 fiscal year budget as revenue funds for these grant awards.

SUBJECT:

City staff have discussed future needs within our water distribution system and feel that one area of concentration should be our daily storage availability. We have looked at two needed improvements and those are first to find a way to utilize the 300,000 gallon water tower on South Hall Street. This tower has been inoperable due to a height and pressure conflict with the million Gallon tank on Tracy Street. The second issue is as the city continues to grow we will need additional storage and pressure in the near future.

Staff met with representatives of OWN Engineering and discussed the possibility of conducting a preliminary engineering report to determine what our best and most economical solutions would be to accomplish these two goals. They have agreed to conduct the Preliminary Engineering on both issues with details in the attached proposed agreement.
