Planning and Zoning **Meeting Minutes** September 18, 2023

The Planning and Zoning Commission met Monday, September 18, 2023 at 5:45 pm in council chambers. Chairman Rick Utter called the hearing to order and tabled the minutes of the previous P&Z meeting because no copy of the minutes were present.

#### Item #1

Rezone Request by Chad Brooks, 630 E Fountain RD, Webb City, MO 64870, asking to change parcels 1817, 1825, and 1919 S Hall Street from A-1 and R-1 to C-2. After discussion, all P&Z Commission members voted in favor and none were opposed. **Rezone Request approv** 

#### Item #2

**Rezone Request by Mathew Hoc** on the east side of 14<sup>th</sup> l



Following discussion, four P&Z Commission members voted to approve, with Mellissa Annis dissenting. Rezone Request approved.

#### Item #3

Rezone Request by Specialty Foods Distributions, Tony Doll CEO, asking for the property at 2105 S Hall Street (approximately 13 acres) to be rezoned from A-1 to I-3. Mr. Doll was present to speak in favor of the request. A number of nearby residents were present to speak against the rezone.

After hearing from all concerned parties present for and against the request, Chairman Utter asked for a vote. Clarence Greeno voted in favor, with the other four members voting against. Rezone Request denied.

Administrator's Report 09/11/23



Council approved funding of the shades for the amphitheater which are now complete although late. The contractor on the same funding continued by making improvements to the structure. There is now new stain, paint and roof repairs done that were certainly needed.

**"Paint The Town Red"** was held last night with an enormous crowd taking over our downtown area. The bonfire was held after and the venders were full all evening.

**Our striping machine** has been put to some good use and we hope to see more soon. They have completed the intersections and roadway on East Street and also Fountain road since the latest round of overlay paving was completed. We hope to get to restriping on Hall Street in the near future.

Progress is continuing on the new Well #`15 located at the tower site on Tracy Street. All analysis to date has been good and volumes appear to be in the mid 3-400 gpm range. Our hope is to have all construction and installation complete and have the new well online by early spring.

City crews have completed the **demolition of the Westhaven Country Club pool** and will be making some improvements soon to improve the tennis court at least to playable conditions.

**Maintenance on the Senior Center facility** has been ongoing by members of the Webb City Waste Water and Public Works. Mostly minor repairs had been requested by the Senior Center staff and this week we have replaced some plumbing connections in the building and the condensation drain. Filters in the HVAC were changed and a leaky toilet repaired. Plans are to begin swapping out their old tube lights with more efficient LED fixtures over the next couple weeks. **The Webb City Parks Department is planning a Holiday Lighting Ceremony** to be held the evening of November 25<sup>th</sup>. This will also coincide with the Webb City Employees VIP night at the Polar Bear Express. The Mayor and hopefully all members of the council will be present to light the park up that night. The event should start at 5:30pm. There will be more information as we move closer to the date.

### The Recycle Gate is now open from 9am to 4pm on Monday and Tuesdays and then 9am to 6pm Wednesdays thru Sundays.

The **tarp replacements for the Farmers Market** have been ordered. The Market has applied for a grant which could cover new tarps for all three of the pavilions (currently just the two are covered) we should receive word in the next week or so if that was approved. Currently the two replacements are on order and the Farmers Market has agreed to 50% funding.

**Budget Meetings** with all departments will start next week. We hope to have the draft budget proposal to council at the October 9<sup>th</sup> meeting.

The second round of paving looks to begin October 16<sup>th</sup>. There may be some grinding occurring prior to that but we hope to begin overlays on that date.

### **Previous Meetings**

Waste Water personnel are continuing with the rebuild of the Walnut Ridge Lift Station. They are adding another holding tank to help with flow issues and more protection from the (NON) disposable wipes that have plagued that area.

We are still waiting for the mobilization of the contractor to begin the manhole rehab project. We hope to seal up 17 manholes and 3 lift stations which should really make an improvement in our inflow and infiltration numbers. This project was recently approved by council and should begin as soon as the vendor can supply the required materials.

Fall Soccer begins this coming Tuesday, **our public works and parks personnel are putting the finishing touches on the new large gravel parking lot,** adjacent to the soccer complex, that we feel will make a real improvement on the recent parking issues we have experienced in the park. Especially with flag football kicking off also next week.

Drilling is complete on the new well and testing is still underway but as of today it looks like we will be able to install a 125 HP motor and hope to have an available constant 300-350 additional gallons per minute from the new water well. Once the initial pump and well are complete Public Works will begin the installation of the concrete building and required equipment similar to what was completed last year on North Hawthorne with that well. We will see significant cost savings as we utilize our own personnel who now have experience in such installation and construction. We are estimating once the current \$300,000 drilling and testing is completed we will see approximately another \$500,000 in expenses to bring the well online.

Our downtown retail merchants & business owners have asked to host an afternoon trick-or-treat event from 1 - 4 p.m. on Tuesday, October 31. Since that day is always a scheduled half day for area schools, this will give parents & care-givers an early safe place to trick-or-treat with their children.

Striping of the Farmers Market was completed we are awaiting a shipment of more yellow paint and maybe some cooler weather to begin the **striping project on the newly paved sections of East Street and Fountain Road.** 

Staff have been working with EPA and Cardinal Valley Habitat Trustees to fund a large concrete pad to be utilized in our bio-solid composting program. Currently we use the gravel area north of the plant to lay out our rows for composting and drying. A concrete pad would reduce wear and tear on our equipment and reduce any water seepage that occurs during the process. We have received word that this project has been approved for funding and we should be contacted in the near future with further details. This will be something we have been working on for many years and are excited to see it become even a possibility.

Parks Department has plans to move the small Caboose located next to the Splash Pad and bring it into the shop for some extensive repairs. The Caboose has been the victim of some serious vandalism over the last several months and it will be much easier to repair in the shop. We plan once the repairs are completed to relocate the Caboose to the area between the Farmers Market and the Depot in the grassy area where the buggy once was. We hope this will give it some better protection and lighting.



Bridge/Roadway Dedication for Line of Duty Death September 25, 2023

### **SUBJECT:**

Allow the police department to dedicate a bridge or roadway in Webb City to honor the line of duty death of Webb City City Marshal Leonard S. Rich on August 10, 1902.

#### **BACKGROUND:**

Missouri State Representative Ann Kelley has reached out to law enforcement agencies in Jasper County to honor Police Officers and Sheriff's Deputies within Jasper County that have died in the line of duty. Rep. Kelley suggested dedicating a bridge or roadway that are on a federally funded roadway in Webb City. The Missouri Department of Transportation has identified two possibilities in Webb City; the bridge over the railroad tracks on Buisness Loop 49 (MacArthur Drive) at the east city limits or Missouri 171 (MacArthur Drive) from the east city limits to the west city limits.

On August 10, 1902, Marshal Leonard S. Rich was shot and killed while responding to a disturbance on "Main Street." Main Street in 1902 is now Broadway Street between Webb & Daugherty Streets.

### **RECOMMENDATION:**

Allow the police department to work with Rep. Kelley's office to dedicate a bridge or roadway in Webb City to honor the line of duty death of City Marshal Leonard S. Rich.

**Reviewed By:** Tracy Craig City Financial Officer Marshal Leonard S. Rich was a Webb City lawman dedicated to bringing law & order to his town.

"On the Saturday night of August 10, 1902 he was responding to a disturbance inside Lizzie Reed's Resort. The trouble was between the owner, Lizzie, & Jim Gideon. The resort was a two-story building on Main Street (At that time, Main Street was Broadway Street from Webb Street East to Webb Corp. where Broadway meets Daugherty Street. Not on the main Street we think of today.<sup>1</sup>) with a parlor & girls upstairs. It seems Gideon had been giving some of the girls a bad time. Lizzie wanted him to take his gang & go downstairs, but he refused.

The Gideon brothers, Joe & Jim, had moved to Webb City from Oklahoma Indian Territory in December 1901. They quickly became known as dangerous men & this was not their first run in with Marshal Rich. Both brothers had been bragging all evening about how they were going to "get a guy" & the deed was going to take place sometime around midnight. Joe would not stop talking about it & kept showing off his gun until Jim finally told him to take the gun back to the hotel room. Only Joe didn't do it & he continued to drink.

Finally Lizzie called Marshal Rich, Marshal James, & Sam Moon, a temporary police officer hired to server during the street fair. At first Marshal Rich tried to talk Jim down & for a while it seemed to be working until they got to the front door. That's when a scuffle between Jim & Marshal Rich broke out. At the same a fight was going on between Joe Gideon & Marshal James. Shots were fired & when it was over Joe Gideon had killed Marshal Rich. Sam Moon had killed Joe Gideon & Jim Gideon had been shot through the arm. Marshal James was badly beaten but survived.

Marshal Leonard Rich was a peace officer & a family man. He married Eve May Eulitle in July 1888. They had a six-year old daughter, Stella. Marshal Rich is buried in the Webb City Cemetery; his stone does not show he died in the line of duty. (In August 2022, Marshal Rich's sacrifice was honored as a memorial stone was added to his gravesite.)

We need to remember the heroes who gave so much to build the place that we call home."

G&A Partners – Payroll Processing Vendor 09.25.23

### **SUBJECT/BACKGROUND:**

To get the level of service needed in a timely manner and at the best price, staff is seeking to change the payroll processing vendor. Currently ADP is being used. G & A Partners offers local service and options that accommodate our needs.

### **RECOMMENDATION:**

Staff recommends the council approve the mayor to sign an agreement with G & A Partners for a one-year contract. After one year, commitment will be on a payroll-topayroll basis. Next level of ADP services approximately \$70,000/year city-wide G & A Partners approximately \$15,500/year city-wide

### FISCAL IMPACT:

Increase city wide compared to current ADP plan would be approximately \$9,800 more per year. There would be an additional one-time implementation fee of \$2,500.
